**I. OPEN SESSION (3:41) P.M.**

**A. Call to Order**

Mr. Le called the meeting to order and called for public comment.

**B. Public Comment:**

**II. CONSENT AGENDA**

**1. Consideration of approving the June 11, 2015 meeting minutes.**

Ms. Covert made a motion to approve the meeting minutes. Ms. Williams seconded the motion which passed unanimously.

**III. REGULAR AGENDA/PUBLIC HEARING AND COMMENT**

**2. Consideration of approving the art and placement of the annual Salmon Sculpture Competition winners at the Salmon Sculpture Garden under the "Outdoor Art Temporary Display Program," located at Sunken Garden Park.**

Mr. White presented background information and introduced Ms. Laura Huckaby, Collections Manager for the San Angelo Museum of Fine Arts, to present her proposal. Ms. Huckaby presented the winners of the competition and five past winners' requests to stay another year. The opening will be on Friday, October 16, 2016 and the Museum asked for approval of the art with artists' discretion on placement. Ms. Franks made a motion to accept the art as presented with artists' discretion for practical placement in the park. Ms. Covert seconded the motion which passed unanimously.

**3. Consideration of approving the art and placement of one of the Downtown San Angelo sheep in front of the Tom Green County Public Library.**

Mr. White presented background information on this item. The Tom Green County Library is requesting approval of the placement of a sheep in front of the library on the southeast corner of the intersection facing the Tom Green County Courthouse. The art work on the sheep will be done by "Brush N Brag". No funding is being requested. The Board discussed the artist and placement of the sheep. Ms. Franks made a motion to accept the sheep as proposed and to approve the placement as presented. Ms. Covert seconded the motion and the motion passed unanimously.

**4. Consideration of approving additional art and its placement at the Red Arroyo Trail, proposed by Art in Uncommon Places.**

Mr. White presented information and background on the trail and additional art work for consideration and its placement. Art work will be funded by grants and fundraisers. Art in Uncommon Places will work with engineering on the placement of art work and safety. Ms. Franks made a motion to accept the proposed art work and its placement as presented. Ms. Covert seconded the motion which passed unanimously.

**5. Updates on art related projects: Red Arroyo art, public art brochure, SNAPS program.**

The glow stones have been installed on the trail at the Red Arroyo and boats are complete. Art in Uncommon Places is waiting on a grant to help complete the pavilions. Due to delays in the construction, the grand opening will probably be in the Spring. An ASU student has completed a brochure for public art but we have not received a copy of it yet. Included as a part of the permanent record is proposed SNAPS brochure.
